(JSI) FOR THE TUBERCULOSIS IMPLEMENTATION FRAMEWORK AGREEMENT (TIFA), GRANTING A SEVEN-AND-A-HALF-MONTH NO-COST EXTENSION, EXTENDING THE PERIOD TO DECEMBER 31, 2024, AND UPDATING THE SCHEDULE OF MILESTONES, CODE OF CONDUCT/MANDATORY DISCLOSURES, AND STANDARD PROVISION FOR FIXED AMOUNT AWARDS

WHEREAS, to accomplish the objectives of the country, it is essential to strengthen linkages with local and international organizations such as the USAID for possible partnerships in education, advocacy, research, and funding assistance in the prevention, diagnosis, treatment, care, and support to TB-infected Filipinos;

WHEREAS, in October 2022, the United States Agency for International Development (USAID) released its Global Tuberculosis (TB) Strategy for the years 2023-2030, aiming to achieve a TB-free world and the TB Sustainable Development Goal;

WHEREAS, through this eight-year strategy, USAID intends to work with its partners worldwide to reach every person with TB, cure those in need of treatment, and prevent new infections and the progression to active TB disease;

WHEREAS, under the Tuberculosis Implementation Framework Agreement (TIFA) of the USAID, a TB Commitment Grant was awarded to the JSI Research & Training Institute Inc. (JSI) as its recipient;

WHEREAS, under Tuberculosis Grant No. 0012-0549-1015, the Isabela Provincial Health Office (IPHO) was awarded as a subrecipient to the TB Commitment Grant amounting to TWO HUNDRED SEVEN THOUSAND NINETY-FOUR U.S. DOLLARS (\$207,094.00) for the implementation of the TIFA;

WHEREAS, the JSI Research and Training Institute, Inc. has proposed the execution of Tuberculosis Commitment Grant #0012-0549-1015 Modification 1, which will effectively extend the implementation of its agreement with the Provincial Government of Isabela. This proposal will grant the Provincial Government of Isabela a seven-and-a-half-month no-cost extension, extending the agreement period to December 31, 2024, and updating the schedule of milestones, code of conduct/mandatory disclosures, and standard provisions for fixed amount awards;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review, this August Body deems the extension of the Memorandum of Agreement between the Provincial Government of Isabela and JSI Research and Training Institute, Inc. to be just, lawful, and promotive of the health policies of the provincial government;

WHEREFORE, upon the motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
