SP-LGU-ISA-0052)

WHEREAS, the Commission on Audit-Provincial Satellite Auditing Office (COA-PSAO) is currently occupying a Six Thousand Two Hundred Sixty Nine (6,269) square meters, more or less portion of the abovesaid property and it intends to continuously possess and utilize it for various improvements and advancements;

WHEREAS, these improvements will greatly contribute for the enhancement of COA-PSAO's delivery of public service and performance of its mandate in maintaining transparency and integrity in the utilization and disbursement of public funds;

WHEREAS, the Office of the Governor has expressed its support to such endeavor and demonstrated its desire to enter into a Deed of Usufruct with COA-PSAO on behalf of the Provincial Government of Isabela that will grant COA-PSAO with usufructuary rights over such portion of the aforesaid property;

WHEREAS, under the Deed of Usufruct, COA-PSAO will exercise usufructuary rights over the parcel of land for a period of twenty (20) years commencing upon the execution of the Deed and renewable for another twenty (20) years at the option of the PGI;

WHEREAS, submitted for the review of this August Body is the proposed Deed of Usufruct to be entered into by the Provincial Government of Isabela and the Commission on Audit-Provincial Satellite Auditing Office which will grant to the latter usufructuary rights over a 6,269 square meter portion, more or less, of the property of the former located in Alibagu, City of Ilagan, Isabela covered by Original Certificate of Title No. 202000129 (Special Patent No. SP-LGU-ISA-0052) issued by the Registry of Deeds for the Province of Isabela;

WHEREAS, as provided in the Deed of Usufruct, it covers a portion of Lot 8200, CAD-403 located at Brgy. Alibagu, Ilagan City, Isabela and is more particularly described as follows:
