WHEREAS, in line with this commitment, the PGI partners and collaborates with institutions and organizations such as the Department of Agrarian Reform (DAR) to advance its agricultural goals for the province;

WHEREAS, this August Body recognizes that the improvement of farm-to-market roads is crucial for enhancing the accessibility of agricultural products, thereby boosting the local economy and providing better opportunities for farmers;

WHEREAS, Honorable Governor Rodolfo T. Albano III sent a letter to this August Body requesting that he be granted the authority to represent the Provincial Government of Isabela in entering into a Memorandum of Agreement with the Department of Agrarian Reform for the implementation of the "Concreting of Sitio Annaronan, San Antonio to Antagan Farm-to-Market Road, Brgy. San Antonio, Cabagan, Isabela" project;

WHEREAS, under the agreement, the Provincial Government of Isabela will receive the amount of Fifteen Million Pesos (PHP 15,000,000.00) to oversee the procurement and implementation of the project;

WHEREAS, the "Concreting of Sitio Annaronan, San Antonio to Antagan Farm-to-Market Road" project is expected to significantly reduce transportation costs and time, ensuring that fresh produce reaches markets more efficiently;

WHEREAS, the DAR's financial subsidy of Fifteen Million Pesos (PHP 15,000,000.00) represents a substantial investment in the province's infrastructure, which will benefit not only farmers but the entire community by fostering economic growth and development;

WHEREAS, after careful review, this August Body determined that granting the Honorable Governor the authority to represent the Provincial Government of Isabela in entering into the said agreement with the DAR is beneficial and promotive of the welfare of the Isabeleños and advances the agricultural goals of the province;

WHEREAS, Section 465(b)(1)(vi) of R.A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and to sign on its behalf all contracts and other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Adrian Philip S. Baysac, duly approved and seconded in a session duly assembled, it was -

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING HONORABLE GOVERNOR RODOLFO T.
