WHEREAS, as the Host Province of the GGI, the PGI is entitled to receive financial benefits derived from its net electricity sales, to be allocated for specific funds, namely: (1) Reforestation, Watershed Management, Health, Environment Enhancement Fund (RWMHEEF); and (2) Development and Livelihood Fund (DLF);

WHEREAS, in compliance with the Department Circular DC2018-08-0021 of the Department of Energy, a Memorandum of Agreement is required to be executed for the establishment of interest-bearing current accounts in favor of the host Local Government Unit to ensure a systematic remittance of the DLF and RWMHEEF to said accounts;

WHEREAS, the establishment of a Memorandum of Agreement between PGI and GGI is deemed necessary to establish interest-bearing current accounts, and to formalize the terms and conditions governing the allocation and disbursement of funds for the benefit of the Province of Isabela and its constituents;

WHEREAS, under Section 465, (b) (1) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, after a careful review, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, premises considered, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR, RODOLFO T.
