DY SR. MEMORIAL HOSPITAL AND MILAGROS ALBANO DISTRICT HOSPITAL

WHEREAS, the Provincial Government of Isabela is committed to improving the healthcare services and facilities for the welfare and benefit of its constituents;

WHEREAS, the Governor Faustino N. Dy Sr. Memorial Hospital and Milagros Albano District Hospital are key healthcare institutions in the province, providing critical medical services to the people of Isabela;

WHEREAS, the Philippine Charity Sweepstakes Office (PCSO) has generously offered to donate two (2) units of patient transport vehicles to the Provincial Government of Isabela for the benefit of Governor Faustino N. Dy Sr. Memorial Hospital and Milagros Albano District Hospital;

WHEREAS, the grant of two (2) units of patient transport vehicles will significantly enhance the operational capabilities of these hospitals, ensuring faster and more reliable emergency medical services to the people of Isabela;

WHEREAS, to effectuate such donation, the execution of a deed of donation is essential to delineate the responsibilities and obligations of both the PGI and the PCSO;

WHEREAS, submitted to this August Body is the proposed Deed of Donation of the Patient Transport Vehicle and Acceptance to be entered into by the PGI and the PCSO;

WHEREAS, after careful review of the said deed, this August Body determined the same to be just, lawful, and promotive of the welfare of Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested upon him by the Sangguniang Panlalawigan;

WHEREAS, this August Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to enter and sign the said Deed of Donation on behalf of the PGI;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded by all members in a session duly assembled, it was –
