WHEREAS, Ordinance No. 07-2023, an Ordinance appropriating the amount of **ONE MILLION SIX HUNDRED EIGHTY THOUSAND FOUR HUNDRED THIRTY THREE PESOS & 17/100 (P1,680,433.17)** derived from savings from vacant positions of Personal Services and the unappropriated Actual Collection in Excess of Estimated Income for Calendar Year 2023 of the Municipality of Ramon, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 07-2023 (Supplemental Budget No. 2 FY 2023 of the Municipality of Ramon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following condition:

1. The utilization of the Appropriation for *Other Professional Services* in the amount of One Million Four Hundred Sixteen Thousand Thirty Seven Pesos & 61/100 (P1,416,037.61) shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;

RESOLVED FURTHER, to require the Municipality of Ramon, Isabela to comply with the herein conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Ramon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JESUS D. LADDARAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Ramon, Isabela through the **Honorable DENNIS JON DELA CRUZ**, Municipal Vice-Mayor.
