WHEREAS, Appropriation Ordinance No. 2023-05, an Ordinance approving Supplemental Budget No. 04 for Fiscal Year 2023 of the Local Government of Palanan in the amount of EIGHT HUNDRED FIFTY THOUSAND PESOS (P850,000.00) from the unimplemented programs, projects and activities (PPAs) under the 5% LDRRM (70% Mitigation Fund) for FY 2023 intended for the food and non-food supplies for the 24/7 operations of the MDRRM office and in the conduct of regular and emergency meetings of the MDRRM Council of the Municipal Government of Palanan, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-05 (Supplemental Budget No. 04 FY 2023) of the Municipality of Palanan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160, and subject further to the following conditions:

- 1. The Appropriation for LDRRMF in the amount of Eight Hundred Fifty Thousand Pesos (P850,000.00) shall adhere to the provisions of Republic Act 10121, DILG Memorandum Circular No. 2012-73 dated April 17, 2012 and NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Supplemental Annual Investment Program shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its implementing Rules and Regulations as supplemented by Local Budget Memorandum No. 85 dated June 15, 2022 and finalized by Local Budget Memorandum No. 85-B dated December 23, 2022, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;
- 2. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of Palanan Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Palanan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable ANGELO A. BERNARDO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Palanan, Isabela through the **Honorable ELIZABETH B. OCHOA**, Municipal Vice-Mayor.
