A RESOLUTION DECLARING THE MUNICIPAL ORDINANCE NO. 2024-267 (SUPPLEMENTAL BUDGET NO. 01 FY 2024) IN THE AMOUNT OF FOUR MILLION SIX HUNDRED FIFTY NINE THOUSAND FOUR HUNDRED NINETY FOUR PESOS & 57/100 (P4,659,494.57) OF THE MUNICIPALITY OF SAN MANUEL, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Municipal Ordinance No. 2024-267, an Ordinance authorizing Supplemental Budget No. 01 Calendar Year 2024 involving an amount of FOUR MILLION SIX HUNDRED FIFTY NINE THOUSAND FOUR HUNDRED NINETY FOUR PESOS & 57/100 (P4,659,494.57) derived from the FY 2023 additional realized income and savings for various PPAs of the Municipal Government of San Manuel, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

NOW THEREFORE, on motion of SP Member DELFINITO EMMANUEL L. ALBANO duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-267 of the Municipality of San Manuel, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The grant of Clothing Allowance shall be in accordance with DBM Budget Circular No. 2024-1 dated April 4, 2024;
- 2. The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
 - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
 - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
 - c. The SSL has been fully implemented;
 - d. The general limitations on PS expenditures are not exceeded;
 - e. The classification of the positions is consistent with the standards and implementing rules and regulations of RA No. 6758;
- 3. The utilization of Terminal Leave Benefits and Monetization of Leave Credits shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC MC No. 41 s. 1998, BC 2013-1 dated April 12, 2013, BC No. 2016-2 dated March 29, 2016;
- 4. Loyalty Pay shall be pursuant to CSC MC No. 6 dated March 1, 2002 P10,000 for the first ten (10) years in government service and P5,000 for the succeeding every five (5) years thereafter;
- 5. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of San Manuel, Isabela to comply with the herein conditions.
