WHEREAS, Ordinance No. 008-2024, an Ordinance authorizing Supplemental Budget No. 02 for Fiscal Year 2024 in the amount of SEVENTEEN MILLION ONE HUNDRED FORTY THREE THOUSAND FIVE HUNDRED TWENTY FIVE PESOS & 14/100 (P17,143,525.14) derived from the FY 2023 actual collection in excess of the estimated income, for payment of 2022 Performance Based Bonus (PBB) and for other various purposes and payment of expenditures of the Municipality of Delfin Albano, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

NOW THEREFORE, on motion of SP Member **DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 008-2024 (Supplemental Budget No. 02 2024) of the Municipality of Delfin Albano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The payment of Performance Based Bonus (PBB) in the amount of Two Million Three Hundred Thirty Two Thousand Six Hundred Eleven Pesos (P2,332,611.00) shall be in accordance with IATF on the Harmonization of National Government Performance Monitoring, Information and Reporting Systems Memorandum Circular No. 2022-1, dated March 24, 2022, on the Guidelines on the Grant of the Performance-Based Bonus (PBB) for Fiscal Year (FY) 2022 under Executive Order (EO) No. 80, s., 2012 and Executive Order No. 201, s. 2016 and DILG-DBM Joint Memorandum Circular No. 2023-001, dated August 4, 2023 on the Amendment to DILG-DBM Joint Memorandum Circular No. 2021-01 for the Grant of Performance-Based Bonus for Officials and Employees of Local Government Units for Fiscal Year 2022;
- 2. The payment of Terminal Leave Benefit in the amount of Eight Hundred Eighty Thousand Three Hundred Twenty Four Pesos & 38/100 (P880,324.38) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on the Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- 3. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Delfin Albano, Isabela to comply with the herein review findings/conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Delfin Albano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
