WHEREAS, the Provincial Government of Isabela (PGI) is committed to supporting the well-being and development of its communities, particularly those most vulnerable to environmental and economic challenges;

WHEREAS, the Office of the President has allocated funds for Special Assistance, Financial or otherwise, to Target Individuals, Communities, or groups of beneficiaries for public health, environment-related activities, and other socio-civic purposes under its Socio-Civic Project Funds (SCPF);

WHEREAS, the PGI has been identified as one of the recipient provinces to receive cash assistance for farmers, fisherfolks, and other marginalized families/households severely affected by El Niño;

WHEREAS, the adverse effects of El Niño have severely impacted the livelihoods of farmers, fisherfolks, and other marginalized households in the Province of Isabela, necessitating immediate financial assistance;

WHEREAS, the Office of the President, recognizing the need for socio-civic support, has allocated FIFTY MILLION PESOS (PHP50,000,000.00) for the grant of cash assistance to the marginalized households in Isabela affected by El Niño under the Socio-Civic Project Funds;

WHEREAS, to effectuate such donation, the execution of a deed of donation is essential to delineate the responsibilities and obligations of both the PGI and the Office of the President;

WHEREAS, submitted to this August Body is the proposed Deed of Donation between the PGI and the Office of the President, which has been carefully reviewed and determined to be just, lawful, and promotive of the welfare of Isabeleños, hence granting the Provincial Governor the necessary authority to enter and sign the said Deed of Donation on behalf of the PGI;

WHEREAS, Section 465(b)(1)(vi) of R.A. No. 7160 empowers the Governor to represent the Province in all its transactions and sign contracts and such other documents relative to the execution of his functions, upon the authority vested in him by the Sangguniang Panlalawigan;

NOW, THEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded by all members in a session duly assembled, it was -
