WHEREAS, the Universal Health Care Act or Republic Act No. 11223, provides that the State shall protect and promote the right to health of all Filipinos, it shall adopt a health care model that provides all Filipinos access to a comprehensive set of quality and cost-effective, promotive, preventive, curative, rehabilitative and palliative health services without causing financial hardship, and prioritizes the needs of the population who cannot afford such services;

WHEREAS, the Department of Health (DOH) is the national government agency of the Republic of the Philippines responsible for ensuring essential public health services to all Filipinos through the provision of quality health care and the regulation of all health services and products;

ALBANO III, ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, TO SIGN, EXECUTE AND ENTER INTO A DEED OF DONATION AND ACCEPTANCE WITH THE DEPARTMENT OF HEALTH, RELATIVE TO THE TURN-OVER OF ONE (1) MOBILE PRIMARY CARE FACILITY (MPCF), AND DESIGNATING GOVERNOR FAUSTINO N. DY, SR. MEMORIAL HOSPITAL (GFNDSMH) AS THE HOSPITAL WHERE THE MPCF SHALL BE ATTACHED

WHEREAS, the Local Government Code (LGC) of 1991 devolved the delivery of health services to the different local government units with the DOH providing assistance, policies, guidelines, and standards for health, as well as tertiary and specialized hospital services;

WHEREAS, Section 6 (c) of R.A. 11223 states that, the DOH and the LGUs shall endeavor to provide a health care delivery system that will afford every Filipino a primary care provider that would act as the navigator, coordinator, and initial and continuing point of contact in the health care delivery system;

WHEREAS, in its commitment to provide quality, timely and accessible primary care services to Isabelinos, the DOH has selected the Provincial Government of Isabela (PGI) as recipient of one (1) Mobile Primary Health Care Facility (MPCF);

WHEREAS, the MPCF is a mobile clinic that provide essential health services which moves from one community to another, especially reaching communities that are cut off from services or those in Geographically Isolated and Disadvantage Areas (GIDAs);

WHEREAS, the MPCF is equipped with an x-ray machine, ultrasound machine, laboratory equipment, and other essential medical tools which will be made available to residents visited by the mobile unit;

WHEREAS, there is a need to designate Governor Faustino N. Dy, Sr. Memorial Hospital (GFNDSMH) as the provincial hospital where the MPCF shall be attached;

WHEREAS, there is a need for the PGI to enter into a Deed of Donation and Acceptance with the DOH, with principal office address at San Lazaro Compound, Tayuman, Sta. Cruz, Manila, represented by its Secretary, Dr. Teodoro J. Herbosa, for the turn-over of one (1) Mobile Primary Care Facility from the DOH to the PGI;

WHEREAS, under Section 465, (b) (l) (vi) of R.A. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign, execute and enter into a Deed of Donation and Acceptance on behalf of the Provincial Government of Isabela; `
