**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 24-001 (SUPPLEMENTAL BUDGET NO. 01 CY 2024) IN THE AMOUNT OF SIXTY THREE MILLION FIVE HUNDRED EIGHTY EIGHT THOUSAND FIVE HUNDRED FIFTY NINE PESOS (P63,588,559.00) OF THE MUNICIPALITY OF ROXAS, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS**

**WHEREAS**, Appropriation Ordinance No. 24-001, an Ordinance approving Supplemental Budget No. 1 of the Municipality of Roxas, Isabela for Calendar Year 2024, in the amount **SIXTY THREE MILLION FIVE HUNDRED EIGHTY EIGHT THOUSAND FIVE HUNDRED FIFTY NINE PESOS (P63,588,559.00)** from the portion of the Share of the Municipality of Roxas, Isabela on the collection of Burley and Native Tobacco Excise Tax for Calendar Year 2020, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 24-001 of the Municipality of Roxas, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. That the Programs/Projects/Activities (PPAs) shall be in accordance with the program objectives of the Share of LGUs from the FY 2020 Collection of Burley and Native Tobacco Excise Taxes under RA No. 8240, as amended by RA No. 10351, and further amended by RA No. 11346 pursuant to Local Budget Memorandum (LBM) No. 86 dated December 14, 2022;
2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Roxas, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Roxas, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable JONATHAN JOSE C. CALDERON**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Roxas, Isabela, through the **Honorable NICK M. SEBASTIAN**, Municipal Vice-Mayor.
