ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA, A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF MOUNTAIN PROVINCE FOR THE IMPLEMENTATION OF THE MALAMATAMAN-BITABIT-CATAO FARM-TO-MARKET ROAD WITH BRIDGE PROJECT

WHEREAS, the Provincial Government of Isabela and the Provincial Government of Mountain Province, in alignment with their shared policies and pursuit of enhancing regional infrastructure and agricultural development, have jointly prioritized the improvement of transportation links for local farmers;

WHEREAS, the Department of Agriculture (DA) has proposed and allocated funds for the construction of a 9.089-kilometer Farm-to-Market Road (FMR) with a bridge, connecting the farms in Paracelis, Mountain Province to the Quezon Public Market in Dummon, Quezon, Isabela;

WHEREAS, the construction of this FMR is crucial for improving access for local farmers in Paracelis, Mountain Province, and Dummon, Quezon, Isabela, enhancing their ability to transport goods to market efficiently;

WHEREAS, to complete the construction of the FMR, it is necessary that a portion of the road traverse through Dummon, Quezon, Isabela, which requires coordination and consent from the Provincial Government of Isabela;

WHEREAS, the Province of Isabela, through the Honorable Rodolfo T. Albano III, has given its consent to the proposed project in a letter dated February 24, 2024, in response to the request for consent by the Provincial Government of Mountain Province through the Honorable Bonifacio Lacwasan Jr.;

WHEREAS, to ensure the effective implementation and maintenance of the project, the Provincial Government of Isabela and the Provincial Government of Mountain Province will execute a Memorandum of Agreement (MOA) that outlines the management and responsibilities for the respective portions of the FMR within their territorial jurisdictions;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code empowers the Governor to represent the Province in all its business transactions and sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREAS, submitted for the review and approval of this August Body is the draft Memorandum of Agreement to be executed by the Provincial Government of Isabela and the Provincial Government of Mountain Province for the implementation of the Malamataman-Bitabit-Catao farm-to-market road with bridge project;

WHEREAS, after a careful review of the Memorandum of Agreement this Body deems it beneficial and advantageous for the Province to grant the Governor the necessary authority to sign the Memorandum of Agreement on behalf of the PGI;

**WHEREFORE**, upon motion of the Honorable Manuel Faustino U. Dy, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE GOVERNOR, HONORABLE RODOLFO T.
