A RESOLUTION DECLARING ORDINANCE NO. 2024-563 (SUPPLEMENTAL BUDGET NO. 03 FY 2024) IN THE AMOUNT OF FOURTEEN MILLION NINE THOUSAND EIGHT HUNDRED SEVENTY PESOS & 40/100 (P14,009,870.40) OF THE CITY OF CAUAYAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Ordinance No. 2024-563, an Ordinance approving Supplemental Budget No. 03 for Fiscal Year 2024 in the amount of **FOURTEEN MILLION NINE THOUSAND EIGHT HUNDRED SEVENTY PESOS & 40/100 (P14,009,870.40)** derived from FY 2023 Savings to fund various PPAs of the City Government of Cauayan, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160.

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-563 of the City of Cauayan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. That the appropriation and utilization of the 20% Development Fund in the amount of Six Million Five Hundred Seventy Nine Thousand Nine Hundred Forty Pesos & 10/100 (P6,579,940.10) shall be subject to the pertinent provisions of DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020;
2. The utilization of the PPAs funded from the balances of the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Years 2018, 2019 and 2020 in the amount of Eight Hundred Fifty Seven Thousand Nine Hundred Fifty Six Pesos & 60/100 (P857,956.60) shall adhere with the provisions of LBM Nos. 83 and 84 both dated November 22, 2021, and LBM No. 86 dated December 14, 2022;
3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the purchase and specifications of the motor vehicle shall be subject to the provisions of Administrative Order No. 14 dated December 10, 2018 and Budget Circular (BC) No. 2022-1 dated February 11, 2022, and BC No. 2022-1A dated March 1, 2023.

RESOLVED FURTHER, to require the City of Cauayan, Isabela to comply with the herein review findings/conditions.

RESOLVED FURTHERMORE, to inform the City of Cauayan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable CAESAR S. DY, JR.**, City Mayor and to the Sangguniang Panlungsod of the City of Cauayan, Isabela through the **Honorable LEONCIO A. DALIN, JR.**, City Vice-Mayor.
