A RESOLUTION DECLARING ORDINANCE NO. 2024-1378 (SUPPLEMENTAL BUDGET NO. 01 FY 2024) IN THE AMOUNT OF TWENTY NINE MILLION FIVE HUNDRED SIXTY NINE THOUSAND ONE HUNDRED TWENTY FIVE PESOS (P29,569,125.00) OF THE MUNICIPALITY OF SAN MARIANO, ISABELA OPERATIVE IN ITS ENTIRETY SUBEJCT TO SOME CONDITION

WHEREAS, Ordinance No. 2024-1378, an Ordinance authorizing Supplemental Budget No. 01 S. 2024 of the Municipality of San Mariano, Isabela involving the amount of TWENTY NINE MILLION FIVE HUNDRED SIXTY NINE THOUSAND ONE HUNDRED TWENTY FIVE PESOS (P29,569,125.00) out of the Actual Collection in Excess of Estimated income and savings for CY 2023 declared as savings embodied in Ordinance No. 2024-1376 of the Local Government of San Mariano, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member VICTOR G. DY** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-1378 of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and further subject to some condition:

- The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
 - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
 - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
 - c. The SSL has been fully implemented;
 - d. The general limitations on PS expenditures are not exceeded;
 - e. The classification of the positions is consistent with the standards and implementing rules and regulations of RA No. 6758;
- 2. The appropriation for Hazard Pay under the Municipal Social Welfare and Development Office in the amount of Forty Thousand Two Hundred Twenty Pesos (P40,220.00) shall be in accordance with DSWD Memorandum Circular No. 05 S. of 2022 and DBM-DSWD Joint Circular No. 1 s. 2018 dated December 1, 2018 on the Rules and Regulations on the Grant of Compensation-Related Magna Carta Benefits to Public Social Workers (PSWs) as supported by AO No. 05, s 2023 and AO No. 06, s. 2023;
- 3. The Utilization of the Appropriation for Other Professional Services amounting to Two Hundred Thousand Pesos (P200,000.00), shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;
- The utilization of the appropriation for the 20% Development Fund shall strictly cover only the development projects prescribed and authorized under DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020;
- 5. All procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations. Further, the acquisition of Motor Vehicles in the amount of Three Hundred Thousand Pesos (P300,000.00)

RESOLVED FURTHER, to inform the Municipality of San Mariano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.
