A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-004 (SUPPLEMENTAL BUDGET NO. 03 CY 2024) IN THE AMOUNT OF TEN MILLION SIXTY SIX THOUSAND FIVE HUNDRED THIRTY SEVEN PESOS (P10,066,537.00) OF THE MUNICIPALITY OF NAGUILIAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Appropriation Ordinance No. 2024-004, an Ordinance approving Supplemental Budget No. 03 of the Municipality of Naguilian, Isabela for Calendar Year 2024, in the amount of TEN MILLION SIXTY SIX THOUSAND FIVE HUNDRED THIRTY SEVEN PESOS (P10,066,537.00) from the Share of the Municipality of Naguilian, Isabela on the collection of Burley and Native Tobacco Excise Tax for Calendar Year 2021, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member VICTOR G. DY** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-004 of the Municipality of Naguilian, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

- 1. The utilization of the projects to be funded from the Local Government share in the Burley and Native Tobacco Excise Tax for the Fiscal Year 2021 amounting to Ten Million Sixty Six Thousand Five Hundred Thirty Seven Pesos (P10,066,537.00) shall adhere with the provisions of LBM No. 89, dated November 10, 2023 on the Guidelines on the release and utilization of the shares of Local Government Units (LGUs) from the FY 2021 and prior years' collection of Excise Tax on locally manufactured Virginia-type cigarettes under Republic Act (RA) No. 7171, and Burley and Native Tobacco Excise Tax Pursuant to RA No. 8240, as amended, by RA No. 11346, chargeable against the allocations to Local Government Units under the FY 2023 General Appropriations Act (GAA), RA No. 11936;
- 2. The proposed projects shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations and item No. 2.3.4 of LBM No. 89 which states that:

"The programs and projects to be implemented by the beneficiary LGUs from their respective shares from tobacco excise taxes shall be in line with the policies, programs, and priorities set in the Agricultural and Fisheries Modernization Program and the Road Map for the Philippine Tobacco Industry, adopted by the DA and NTA for the period. Moreover, beneficiary LGUs are highly encouraged to allocate at least twenty-five percent (25%) of their total share for cooperative programs, livelihood projects, and financial support for registered tobacco farmers."

3. The appropriation for the following account should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:
