A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-01 (SUPPLEMENTAL BUDGET NO. 01-2024) IN THE AMOUNT OF FIFTY NINE MILLION ONE HUNDRED TWENTY TWO THOUSAND NINE HUNDRED TWENTY PESOS (P59,122,920.00) OF THE MUNICIPALITY OF QUEZON, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2024-01, an Ordinance authorizing the appropriation of Supplemental Budget No. 01-2024 in the amount of **FIFTY NINE MILLION ONE HUNDRED TWENTY TWO THOUSAND NINE HUNDRED TWENTY PESOS (P59,122,920.00)** from the Share of the Municipality of Quezon, Isabela on the collection of Burley and Native Tobacco Excise Tax for Fiscal Years 2020 and 2021, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member VICTOR G. DY** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-01 (Supplemental Budget No. 1 FY 2024) of the Municipality of Quezon, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. That the Programs/Projects/Activities (PPAs) shall be in accordance with the program objectives of the Share of LGUs from the FYs 2020 and 2021 Collection of Burley and Native Tobacco Excise Taxes under RA No. 8240, as amended by RA No. 10351, and further amended by RA No. 11346 pursuant to Local Budget Memorandum (LBM) No. 86 dated December 14, 2022 and Local Budget Memorandum (LBM) No. 89 dated November 10, 2023;
2. That the LBP Form No. 9 shall be prepared consistent with the Revised Chart of Accounts for LGUs, under COA Circular No. 2015-009 dated December 1, 2015 and that the supplemental AIP shall be properly accomplished providing therein complete information for the PPAs. A copy of which shall be provided to this Office;
3. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Quezon, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Quezon, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JIMMY S. GAMAZON, JR.**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quezon, Isabela through **Honorable DARYL G. GASCON**, Municipal Vice-Mayor.


