A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 04 S. 2024 (SUPPLEMENTAL BUDGET NO. 02 FY 2024) IN THE AMOUNT OF FIFTY NINE MILLION THREE HUNDRED SEVEN THOUSAND THREE HUNDRED NINETY TWO PESOS (P59,307,392.00) OF THE MUNICIPALITY OF QUIRINO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 04 Series of 2024, an Ordinance authorizing Supplemental Budget No. 02 for FY 2024 of the Local Government Unit of Quirino, Isabela involving an amount of **FIFTY NINE MILLION THREE HUNDRED SEVEN THOUSAND THREE HUNDRED NINETY TWO PESOS (P59,307,392.00)** from the remaining balance of the Share of the Municipality of Quirino, Isabela on the collection of Burley and Native Tobacco Excise Tax for Calendar Year 2020, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 04 S. 2024 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. That the Programs/Projects/Activities (PPAs) shall be in accordance with the program objectives of the Share of LGUs from the FY 2020 Collection of Burley and Native Tobacco Excise Taxes under RA No. 8240, as amended by RA No. 10351, and further amended by RA No. 11346 pursuant to Local Budget Memorandum (LBM) No. 86 dated December 14, 2022;
2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Quirino, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHER, to inform the Municipality of Quirino, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable EDWARD D. JUAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quirino, Isabela through the **Honorable VICTOR EMMANUEL G. CALLANGAN**, Municipal Vice-Mayor.
