A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 24-002 (SUPPLEMENTAL BUDGET NO. 02 CY 2024) IN THE AMOUNT OF TWENTY EIGHT MILLION PESOS (P28,000,000.00) OF THE MUNICIPALITY OF ROXAS, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Appropriation Ordinance No. 24-002, an Ordinance approving Supplemental Budget No. 2 of the Municipality of Roxas, Isabela for Calendar Year 2024, in the amount **TWENTY EIGHT MILLION PESOS (P28,000,000.00)** derived from New Revenue Source - Loan Proceeds for the Acquisition of Land to serve as sites for various infrastructure projects of the Municipal Government of Roxas, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member VICTOR G. DY** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 24-002 of the Municipality of Roxas, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. That the Twenty Eight Million Pesos (P28,000,000.00) loan of the Municipality of Roxas, Isabela, must be governed by Sec. 324 (b) of RA 7160, which states:

“That the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned.”

2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Roxas, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Roxas, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JONATHAN JOSE C. CALDERON**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Roxas, Isabela through the **Honorable NICK M. SEBASTIAN**, Municipal Vice-Mayor.
