WHEREAS, to upgrade and update the capabilities of service providers and their supervisors to comply with quality standards for various ECCD programs, it is imperative to provide continuous training, capacity-building initiatives, and adequate resources to ensure that the personnel are well-equipped to deliver high-quality early childhood education and care services;

WHEREAS, the partnership between the Provincial Government of Isabela (PGI) and the Early Childhood Care and Development (ECCD) Council aims to facilitate the transfer of funds, which will be utilized to compensate assessment partners and volunteers who play a vital role in the implementation and monitoring of these programs;

WHEREAS, for its proper implementation, it requires the execution of a Memorandum of Agreement between the PGI and the Early Childhood Care and Development (ECCD) Council;

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Provincial Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREFORE, premises considered, upon motion of Honorable Ed Christian S. Go, duly approved and seconded in a session duly assembled, it was -
