A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2023-03 (SUPPLEMENTAL BUDGET NO. 03 SERIES OF 2023) IN THE AMOUNT OF SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (P7,500,000.00) OF THE MUNICIPALITY OF SAN MATEO, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITION

WHEREAS, Appropriation Ordinance No. 2023-03, an Ordinance authorizing the appropriation of Supplemental Budget No. 3 series of 2023 in the amount of **SEVEN MILLION FIVE HUNDRED THOUSAND PESOS (P7,500,000.00)** from Collection of Occupancy fee of Stalls in Public Market with expired lease contracts of the Municipality of San Mateo, Isabela, was submitted to this office for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-03 (Supplemental Budget No. 3 series 2023) of the Municipality of San Mateo, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following condition:

1. The utilization of the appropriation for Other General Services in the amount of Four Million Three Hundred Fifty Thousand Pesos (P4,350,000.00), shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;

RESOLVED FURTHER, to require the Municipality of San Mateo, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of San Mateo, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.


