WHEREAS, the Provincial Government of Isabela is the registered owner of a parcel of land located at Brgy. Alibagu, Ilagan City, Isabela containing a land area of Five Hundred Thirteen Thousand One Hundred Fifty-Five (513,155) square meters, more or less, covered under Original Certificate of Title No. 2020000129 (Special Patent No. SP-LGU-ISA-0052), issued by the Registry of Deeds of the Province of Isabela;

WHEREAS, the Philippine Drug Enforcement Agency-Isabela Provincial Office (PDEA-Isabela) has previously established its Office within the abovementioned parcel of the land, more particularly a specific portion of Lot 8200, CAD-403, containing an area of One Thousand Nine Hundred Forty-Four (1,944) square meters, more or less;

WHEREAS, to improve efficiency and employee skills, PDEA-Isabela requires more office space to meet growing demands and enhance drug enforcement. By optimizing building use it will support officer recruitment, resulting in a more effective agency benefiting Isabeleños;

WHEREAS, the Office of the Governor has expressed its support to such endeavor and demonstrated its desire to enter into a Deed of Usufruct with PDEA-Isabela on behalf of the Provincial Government of Isabela that will grant PDEA-Isabela with usufructuary rights over such portion of the aforesaid property;

WHEREAS, under the Deed of Usufruct, PDEA-Isabela will exercise usufructuary rights over the parcel of land for a period of five (5) years commencing upon the execution of the Deed and renewable for another five (5) years at the option of the PGI;

WHEREAS, submitted for the review of this August Body is the proposed Deed of Usufruct to be entered into by the Provincial Government of Isabela and the Philippine Drug Enforcement Agency-Isabela Provincial Office which will grant to the latter usufructuary rights over a 1,944 square meter, more or less, portion of the abovementioned property located in Alibagu, City of Ilagan, Isabela;

WHEREAS, after careful review, this August Body has determined the Deed of Usufruct to be just and lawful. As such, this August Body agreed that granting the Honorable Governor the necessary authority to sign such deed on behalf of the Provincial Government of Isabela to be beneficial and advances the welfare of the Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Clifford R. Raspado duly approved and seconded in a session duly assembled, it was —
