**WHEREAS**, the Department of Human Settlements and Urban Development (DHSUD) created under Republic Act No. 11201 is empowered to formulate and prescribe land use planning guidelines and zoning standards and regulations for the guidance of cities and municipalities in the formulation of their respective Comprehensive Land Use Plans (CLUPs) and Zoning Ordinances (ZOs);

**WHEREAS**, Memorandum Circular No. 2021-005 of the DHSUD has been issued providing for the revised review and approval processes of CLUPs and ZOs of Highly Urbanized Cities (HUCs), Independent Component Cities (ICCs), Component Cities and Municipalities (CCMs) and Metro Manila Cities and Municipality (MMCMs);

**WHEREAS**, the Technical Working Group of PLUC tediously evaluating the CLUP and Zonification of the Municipality of Angadanan, the PLUC issued Resolution No. 01, Series of 2024, finding their CLUP to be consistent and in accordance with the guidelines and policy standards set by the DHSUD. Moreover, the requirement for the mainstreaming of disaster risk reduction and climate change adaptation has also been approved and conforms to the Provincial Development and Physical Framework Plan;

**WHEREAS**, Section 468 (a) (2) (vii) of the Local Government Code has empowered the Sangguniang Panlalawigan to review the Comprehensive Land Use Plans and Zoning Ordinances of component cities and municipalities and adopt a Comprehensive Provincial Land Use Plan, subject to existing laws;

**WHEREAS**, based on the endorsement made by the PLUC and the power vested upon the Sanggunian to review the Comprehensive Land Use Plan and Zoning Ordinance of a Municipality, the Ten-Year CLUP of the Municipality of Angadanan, Isabela is hereby approved;

**WHEREAS**, in view of the foregoing, upon motion of Honorable Mary Grace D. Arreola, duly approved and seconded in a session duly assembled, it was -
