WHEREAS, the Province of Isabela is committed to advancing sustainable land use and environmental stewardship in alignment with its policies and practices aimed at preserving natural resources, promoting responsible land management, and fostering socio-economic development;

WHEREAS, Atty. Christopher A. Mamauag has submitted a Letter-Request dated July 10, 2024, seeking an official endorsement from the Provincial Government of Isabela (PGI) in the form of a Sangguniang Panlalawigan Resolution for his application for a Forest Land Grazing Management Agreement (FLGMA) with the Department of Environment and Natural Resources (DENR);

WHEREAS, the application pertains to a forest land area located in Barangay San Antonio, Cabagan, Isabela, measuring 72.81 hectares, and a portion of Minagbag, Quezon, Isabela, measuring 32.85 hectares;

WHEREAS, in light of the foregoing considerations, the Sangguniang Panlalawigan of Isabela hereby extends its unequivocal support and expresses no objection to the Forest Land Grazing Management Agreement proposed by Atty. Christopher A. Mamauag, acknowledging the substantial potential of this agreement to advance sustainable land management practices and to make a significant positive impact on both the local economy and environmental stewardship;
