**WHEREAS**, it is the policy of the Provincial Government of Isabela to protect and promote the welfare of its populace, wherever they may be;

**WHEREAS**, in line with this policy, the PGI has established satellite office in Metro Manila in order to cater to the marginalized and specific segments of the population who are in need of immediate assistance and support from the Provincial Government and specifically to cater to migrants workers so that our fellow Isabeleños can continue to avail of the Provincial Government's services;

**WHEREAS**, in this light, the Provincial Governor established a PGI satellite office in a rental property, which is owned by Ms. Rina S. Reyes, and is situated at #16 Kayumanggi Street, West Triangle Homes, Quezon City, Metro Manila;

**WHEREAS**, premises considered, upon motion of Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was –
