A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-04 (SUPPLEMENTAL BUDGET NO. 04 CY 2024) IN THE AMOUNT OF SEVEN MILLION SIX HUNDRED NINETY ONE THOUSAND EIGHTY FOUR PESOS AND 44/100 (P7,691,084.44) OF THE MUNICIPALITY OF BENITO SOLIVEN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2024-04, an ordinance authorizing Supplemental Budget No. 04 for Calendar Year 2024 of the Local Government of Benito Soliven, Isabela, amounting to **SEVEN MILLION SIX HUNDRED NINETY ONE THOUSAND EIGHTY FOUR PESOS AND 44/100 (P7,691,084.44)** from Savings of CY 2023 of the Municipality of Benito Soliven, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-04 of the Municipality of Benito Soliven, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. The grant of Terminal Leave Benefits and Monetization of Leave Credits in the amount of Four Hundred Twenty Five Thousand Pesos (P425,000.00) and One Million Five Hundred Ninety Nine Thousand Nine Hundred Ninety Eight Pesos (P1,599,998.00) respectively, shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC Memorandum Circular No. 41, s. 1998, BC No. 2013-1 dated April 12, 2013, BC No. 2016-2 dated March 29, 2016 and CSC Memorandum Circular No. 02, s. 2016;
2. That the appropriation for Other General Services in the amount of Eight Hundred Thousand Pesos (P800,000.00) shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units.
3. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of Benito Soliven, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Benito Soliven, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable ROBERTO T. LUNGAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Benito Soliven, Isabela through the **Honorable JOHN PAUL S. AZUR**, Municipal Vice-Mayor.
