WHEREAS, Appropriation Ordinance No. 2024-1386, an Ordinance authorizing Supplemental Budget No. 03 Calendar Year 2024 in the amount of TEN MILLION SEVEN HUNDRED THIRTY THOUSAND PESOS (P10,730,000.00) from the unappropriated ending balance of Supplemental Budget No. 01 FY 2024 of the Municipal Government of San Mariano, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

A RESOLUTION DECLARING ORDINANCE NO. 002-2024 (SUPPLEMENTAL BUDGET NO. 01 FY 2024) IN THE AMOUNT OF THIRTY ONE MILLION TWENTY FOUR THOUSAND ONE HUNDRED EIGHTY EIGHT PESOS AND 39/100 (P31,024,188.39) OF THE MUNICIPALITY OF DIVILACAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-1386 of the Municipality of San Mariano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The appropriation and utilization of the 20% Development Fund shall be subject to the pertinent provisions of DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020 and DILG-DBM Joint Memorandum Circular No. 01 dated March 27, 2020;
- 2. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of San Mariano, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of San Mariano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable Edgar T. Go,** Municipal Mayor, and to the Sangguniang Bayan of the Municipality of San Mariano, Isabela through the Honorable **DEAN ANTHONY G. DOMALANTA**, Municipal Vice-Mayor.
