A RESOLUTION INTERPOSING NO OBJECTION TO AND EXPRESSING SUPPORT FOR THE DEVELOPMENT OF A 230kV TRANSMISSION LINE PROJECT IN THE PROVINCE OF ISABELA TO BE IMPLEMENTED BY THE SMC GLOBAL LIGHT AND POWER CORPORATION (SGLPC)

WHEREAS, Republic Act No. 11361, otherwise known as the "Anti-Obstruction of Power Lines Act", establishes the State policy of ensuring uninterrupted conveyance of electricity from generating plants to end users, and protect the integrity and reliability of the country's transmission, sub-transmission, and distribution systems by keeping the land beneath, the air spaces surrounding and the area traversed by power lines clear of dangerous obstructions;

WHEREAS, the primary goal of a transmission system is to transport electrical energy efficiently over long distances, minimize losses and maintain power quality within the area. Upgrade and expansion of transmission lines will provide more avenues for the delivery of low-cost energy;

WHEREAS, the Provincial Government of Isabela (PGI) acknowledges the importance of developing transmission line projects to carry and safely deliver energy from generating power plants to substations that alter the voltage and transmit it to its consumers;

WHEREAS, submitted for the review of this August Body is the request of SMC Global Light and Power Corporation (SGLPC) for the issuance of a Sangguniang Panlalawigan Resolution supporting and interposing no objection to their development of a 230kV Transmission Line Project in the Province of Isabela;

WHEREAS, after a careful review of SGLPC's corporate credentials and capabilities and with due regard to their compliance with the necessary permits and licenses, and the benefits of establishing a 230kV transmission line project in the advancement of local goals on energy security, this August Body finds no cogent reason to deny the said request of SGLPC and hereby declares its support to their project in the Province of Isabela;

WHEREFORE, upon motion of the Honorable Edward S. Isidro, duly approved and seconded in a session duly assembled, it was —

RESOLVED, AS IT HEREBY RESOLVES, TO PASS A RESOLUTION INTERPOSING NO OBJECTION TO AND EXPRESSING SUPPORT FOR THE DEVELOPMENT OF A 230kV TRANSMISSION LINE PROJECT IN THE PROVINCE OF ISABELA TO BE IMPLEMENTED BY THE SMC GLOBAL LIGHT AND POWER CORPORATION (SGLPC).
