WHEREAS, the Provincial Government of Isabela (PGI) is steadfast in its commitment to implementing the principles of the Universal Health Care Act by improving access to essential medications and pharmaceutical services, especially for underserved and geographically isolated areas;

WHEREAS, the Local Government Unit (LGU) of Divilacan recognizes the urgent need for an effective pharmacy service system and seeks to collaborate with the PGI to establish a reliable referral framework that will ensure the timely distribution of critical medicines to patients, particularly in rural communities;

WHEREAS, this collaboration is designed to bridge existing gaps in healthcare delivery by establishing an outsourced pharmacy service and referral network that will allow for efficient medication procurement and distribution to healthcare facilities within Divilacan and surrounding areas;

WHEREAS, healthcare providers, especially in remote areas, frequently face challenges in maintaining adequate stocks of necessary medicines, and the proposed partnership will help ensure that essential drugs are always available when needed, thereby improving patient outcomes;

WHEREAS, the PGI and LGU of Divilacan share a common objective of strengthening their healthcare systems, with a focus on enhancing access to affordable medicines through an organized and responsive pharmacy service partnership;

WHEREAS, after thorough review, this Body deems it beneficial and advantageous for the Province of Isabela to grant the Provincial Governor, Hon. Rodolfo T. Albano III, the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela with the Local Government Unit of Divilacan for the establishment of outsourced pharmacy services and a referral system;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code of 1991 empowers the Provincial Governor to represent the Province in all its business transactions and to sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly seconded, it was—

RESOLVED, AS IT IS HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
