A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T. ALBANO III, TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A MEMORANDUM OF AGREEMENT WITH THE LOCAL GOVERNMENT UNIT OF DIVILACAN FOR OUTSOURCED BIRTHING CENTER SERVICES AND STREAMLINED REFERRAL SYSTEM

WHEREAS, it is the policy of the Provincial Government of Isabela to promote the health of its people and to ensure that Isabeleños can avail themselves of healthcare services that are quality and accessible services;

WHEREAS, in accordance with the provisions outlined in Republic Act No. 11223, also known as the Universal Health Care Act, the Provincial Government of Isabela aims to develop effective referral systems and coordination mechanisms between rural health and birthing centers, as well as higher-level healthcare facilities. This initiative seeks to guarantee that individuals in need of specialized medical attention or emergency services can be efficiently referred and transferred to suitable healthcare facilities;

WHEREAS, the Local Government Unit of Divilacan aims to establish a collaboration to enhance birthing center services and to create an efficient referral system for maternal healthcare, ensuring that patients from the Rural Health Unit of Divilacan receive timely and appropriate care, particularly in emergency situations;

WHEREAS, this partnership is intended to improve healthcare delivery by outsourcing birthing center services, ensuring that maternal healthcare in Divilacan is effectively supported, and enhancing the referral system with other healthcare providers for more specialized or urgent needs;

WHEREAS, the Provincial Government of Isabela acknowledges the importance of this partnership to ensure that essential healthcare services, including safe childbirth and maternal care, are made accessible to the constituents of Divilacan;

WHEREAS, both the Provincial Government of Isabela and the Municipal Government of Divilacan see mutual benefits in formalizing this agreement to support outsourced birthing center services and to streamline the referral system;

WHEREAS, after thorough review, this Body deems it beneficial and advantageous for the Province of Isabela to grant the Provincial Governor, Hon. Rodolfo T. Albano III, the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela with the Local Government Unit of Divilacan for the establishment of outsourced birthing center services and a referral system;

WHEREAS, Section 465 (b)(1)(vi) of the Local Government Code of 1991 empowers the Provincial Governor to represent the Province in all its business transactions and to sign on its behalf all contracts and such other documents upon authority of the Sangguniang Panlalawigan;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly seconded, it was—

RESOLVED, AS IT IS HEREBY RESOLVES, TO PASS A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, THE HONORABLE RODOLFO T.
