**A RESOLUTION DECLARING ORDINANCE NO. 2024-581 (SUPPLEMENTAL BUDGET NO. 07 FY 2024) IN THE AMOUNT OF TEN MILLION FOUR HUNDRED SEVENTY SEVEN THOUSAND THREE HUNDRED ONE PESOS (P10,477,301.00) OF THE CITY OF CAUAYAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS**

**WHEREAS**, Ordinance No. 2024-581, an Ordinance approving Supplemental Budget No. 07 for Fiscal Year 2024 in the amount of **TEN MILLION FOUR HUNDRED SEVENTY SEVEN THOUSAND THREE HUNDRED ONE PESOS (P10,477,301.00)** derived from the share of the City of Cauayan, Isabela on the collection of Burley and Native Tobacco Excise Tax for Calendar Year 2021 for the implementation of various PPAs of the City Government of Cauayan, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

**WHEREAS**, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160.

**NOW THEREFORE**, on motion of SP Member **DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2024-581 of the City of Cauayan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. That the Programs/Projects/Activities (PPAs) shall be in accordance with the program objectives of the Share of LGUs from the FY 2021 Collection of Burley and Native Tobacco Excise Taxes under RA No. 8240, as amended by RA No. 10351, and further amended by RA No. 11346 pursuant to Local Budget Memorandum (LBM) No. 89 dated November 10, 2023;
2. That the account titles and codes used by the City shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, Prescribing the Revised Chart of Accounts for LGUs;
3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the City of Cauayan, Isabela to comply with the herein review findings/conditions.

**RESOLVED FURTHERMORE**, to inform the City of Cauayan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable CAESAR S. DY JR.**, City Mayor, and to the Sangguniang Panlungsod of the City of Cauayan, Isabela through the **Honorable LEONCIO A. DALIN, JR.**, City Vice-Mayor.
