A RESOLUTION DECLARING ORDINANCE NO. 2024-025 (SUPPLEMENTAL BUDGET NO. 03 FY 2024) IN THE AMOUNT OF TWO MILLION FOUR HUNDRED FIFTY THOUSAND NINE HUNDRED PESOS (P2,450,900.00) OF THE MUNICIPALITY OF JONES, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Ordinance No. 2024-025, an Ordinance authorizing Supplemental Budget No. 03 S. 2024 of the Municipality of Jones, Isabela involving the amount of TWO MILLION FOUR HUNDRED FIFTY THOUSAND NINE HUNDRED PESOS (P2,450,900.00) derived from PS savings for the creation of Two (2) Midwife II with SG-11 and Purchase of Two (2) units vehicle (7-seating capacity), was submitted to this office for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 2024-025 of the Municipality of Jones, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

- The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
  - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
  - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
  - c. The SSL has been fully implemented;
  - d. The general limitations on PS expenditures are not exceeded;
- 2. The acquisition of motor vehicles shall be subject to the provisions of Budget Circular No. 2022-1 dated February 11, 2022 and Administrative Order (AO) No. 14 dated December 10, 2018;
- 3. That all procurement activities shall be governed by the Government Procurement Reform Act (RA No. 9184) and its 2016 revised IRR.

**RESOLVED FURTHER**, to inform the Municipality of Jones, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable NHEL C. MONTANO**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Jones, Isabela through the **Honorable EVELYN R. RASPADO**, Municipal Vice-Mayor.
