WHEREAS, submitted for the review and approval of this Honorable Body is the proposed Memorandum of Agreement between the PGI and the DBP;

WHEREAS, after a careful review, this Honorable Body deems the Memorandum of Agreement between the PGI and the DBP to be just, lawful, and promotive of the policies of the PGI:
