WHEREAS, it is the policy of the Provincial Government of Isabela to prioritize the health and well-being of its people by ensuring, among others, access to an adequate supply of nutritious food for all;

WHEREAS, the Provincial Government of Isabela is committed to addressing malnutrition, especially among severely underweight children aged three years and above, by implementing immediate and sustained interventions to improve their health and overall well-being;

WHEREAS, SN-Aboitiz Power (SNAP) Magat, Inc. has expressed its commitment to support the Provincial Government's efforts to resolve malnutrition by allocating a portion of its Corporate Social Responsibility (CSR) Fund for the purchase and donation of premium-brand milk cans, which will be distributed to the beneficiaries of the Supplemental Milk Feeding Program;

WHEREAS, submitted for this review and approval of this August Body is the proposed Memorandum of Agreement to be entered into by the Provincial Government of Isabela and SNAP-Magat, Inc. for the implementation of the "Supplemental Milk Feeding Program of PLGU Isabela". Under such an agreement, SNAP-Magat, Inc. will commit funds from its Corporate Social Responsobility Fund for the acquisition and delivery of premium-brand milk cans in favor of the Provincial Government of Isabela, supporting the latter's milk feeding program;

WHEREAS, Section 465(b)(1)(vi) of R. A. No. 7160 empowers the Provincial Governor to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, the partnership between the Provincial Government of Isabela and SNAP-Magat, Inc. through a Memorandum of Agreement (MOA) will facilitate the efficient implementation of the Supplemental Milk Feeding Program, ensuring that much-needed nutrition reaches severely underweight children in the province;

WHEREAS, after careful review of such an agreement, this August Body finds the same to be just, lawful, and promotive of the health policies of the Provincial Government of Isabela hence it determined that it is in the best interest of the Provincial Government of Isabela to authorize Honorable Governor Rodolfo T. Albano III to sign, on behalf of the province, the Memorandum of Agreement with SNAP-Magat, Inc. for the implementation of this crucial program;

WHEREFORE, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –
