WHEREAS, it is the policy of the State to promote agricultural development by providing the policy framework, public investments, and support services needed for domestic and export-oriented business enterprises;

WHEREAS, to fulfill this mandate, the Department of Agriculture thru the Philippine Rural Development Project (PRDP), launched the "Subproject Aromatic and Pigmented Rice Production and Marketing Enterprise." It is an Investment for Rural Enterprises, and Agricultural and Fisheries Productivity (I-REAP) Component funded sub-project for the development of the Aromatic and Pigmented Rice Industry;

WHEREAS, it aims to promote and market the unique varieties of aromatic and pigmented rice produced by Isabeleño farmers, which provides new opportunities for the local farmers and boosts the economy of the region;

WHEREAS, this sub-project was previously awarded to Isabela Grains Production and Marketing Cooperative (IGPMC) but its operation was cut short due to intra-corporate disputes between the former Manager and incumbent Chairman of IGPMC;

WHEREAS, to avoid further delay in the subproject's implementation, the PGI Provincial Project Management and Implementing Unit (PPMIU), the Municipal Local Government Unit of Roxas (MLGU Roxas), IREAP Project Supporting Office, and the Regional Project Coordination Office (RPCO) have decided to implement an operational rehabilitation plan for the subproject;

WHEREAS, the proposed rehabilitation plan requires the partnership with an FCA (Farmers, Cooperatives, and Associations) Co-Manager to undertake the Aromatic and Pigmented Rice Production, Processing and Marketing. After a careful review assessment of the eligibility of the FCAs with letter of intent based on PRDP IREAP Guidelines, it concluded that the Roxas Isabela Tobacco Farmers Credit Cooperative (RITFCC) is compliant and qualified to become the FCA Co-Manager;

WHEREAS, RITFCC submitted Board Resolution No. 04, S. 2024 entitled, "A Resolution Requesting the Provincial Government of Isabela for Co-Management of the PRDP I-REAP Subproject Aromatic and Pigmented Rice Production and Marketing Enterprise";

WHEREAS, for proper implementation of the subproject, it requires the execution of Memorandum of Agreement between the PGI, Municipal Local Government Unit of Roxas, Isabela, and the Roxas Isabela Tobacco Farmers Credit Cooperative (RITCC);

WHEREAS, under Section 465 (b) (vi) of R. A. No. 7160, the Governor is empowered to represent the Province in all its transactions and sign on its behalf all contracts and such other documents upon the issuance of an authority by the Sangguniang Panlalawigan;

WHEREAS, this Body deems it beneficial and advantageous for the Province to grant the Provincial Governor the necessary authority to sign the Memorandum of Agreement on behalf of the Provincial Government of Isabela;

WHEREAS, premises considered, upon motion of Honorable Clifford R. Raspado, duly approved and seconded in a session duly assembled, it was -
