RESOLVED, to declare Appropriation Ordinance No. 05 S. 2024 of the Municipality of Burgos, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- That the Programs/Projects/Activities (PPAs) shall be in accordance with the program objectives of the Share of LGUs from the FY 2021 Collection of Burley and Native Tobacco Excise Taxes under RA No. 8240, as amended by RA No. 10351, and further amended by RA No. 11346 pursuant to Local Budget Memorandum (LBM) No. 89 dated November 10, 2023;
- 2. That the appropriation for the following accounts should be properly classified to specific Object of Expenditures and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

3. The proposed projects shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.
