WHEREAS, Appropriation Ordinance No. 2023-04, an Ordinance authorizing the 4th Supplemental Budget of the Municipality of Benito Soliven, Isabela for the Calendar Year 2023 involving the amount of **ONE MILLION FOUR HUNDRED TWENTY THOUSAND FIVE HUNDRED FIFTY THREE PESOS & 30/100 (P1,420,553.30)** derived from the unexpended balance from Trust Fund to General Fund and Interest Subsidy Fund from Development Bank of the Philippines (DBP) to supplement the fund for the General Public Services regular operation and to support Barangay Election of the Municipal Government of Benito Soliven, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2023-04 of the Municipality of Benito Soliven, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The appropriation for Monetization of Leave Credits in the amount of Five Hundred Ninety Five Thousand Eight Hundred Thirty Three Pesos & 33/100 (P595,833.33) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016 on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on the Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
2. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of Benito Soliven, Isabela to comply with the herein review finding and/or condition and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Benito Soliven, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable ROBERTO T. LUNGAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Benito Soliven, Isabela through the **Honorable JOHN PAUL S. AZUR**, Municipal Vice-Mayor.
