THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 13 S. 2024 of the Municipality of Quirino, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- The utilization of the appropriation for Representation Allowance and Transportation Allowance shall be in accordance with DBM Local Budget Circular No. 157 dated May 3, 2024, the Updated Rules and Regulations on the Grant of Representation and Transportation Allowances (RATA) to Officials of Local Government Units (LGUs) For FY 2024 and Years Thereafter;
- 2. The grant of Clothing Allowance shall be in accordance with DBM Budget Circular No. 2024-1 dated April 4, 2024.

RESOLVED FURTHER, to require the Municipality of Quirino, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Quirino Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable EDWARD D. JUAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Quirino, Isabela through the **Honorable VICTOR EMMANUEL G. CALLANGAN**, Municipal Vice-Mayor.
