WHEREAS, Appropriation Ordinance No. 447 S. 2024, An Ordinance authorizing Supplemental Budget 02, s. 2024 involving the amount of FIVE MILLION THREE HUNDRED FORTY FOUR THOUSAND FOUR HUNDRED NINE PESOS & 61/100 (P5,344,409.61) derived from FY 2024 additional realized income for the increase in Representation Allowance, Transportation Allowance and funding of various PPAs of the Municipal Government of Dinapigue, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

### THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 447 S. 2024 of the Municipality of Dinapigue, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

- 1. The utilization of the appropriation for Representation Allowance and Transportation Allowance shall be in accordance with DBM Local Budget Circular No. 157 dated May 3, 2024, the Updated Rules and Regulations on the Grant of Representation and Transportation Allowances (RATA) to Officials of Local Government Units (LGUs) For FY 2024 and Years Thereafter;
- The utilization of Terminal Leave Benefits shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC MC No. 41 s. 1998, BC 2013-1 dated April 12, 2013, BC No. 2016-2 dated March 29, 2016;
- 3. The appropriation for Other General Services amounting to Two Million Nineteen Thousand Nine Hundred Ninety Five Pesos & 61/100 (P2,019,995.61) shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;
- 4. The appropriation for Donations amounting to Nine Hundred Forty Six Thousand Five Hundred Pesos (P946,500.00) shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
- 5. The appropriation for LDRRMF shall adhere to the provisions of Republic Act 10121, DILG Memorandum Circular No. 2012-73 dated April 17, 2012 and NDRRMC-DBM-DILG JMC No. 2013-1 dated March 25, 2013. Provided further, that the LDRRMF Supplemental Annual Investment Program shall be reviewed by the Office of Civil Defense (OCD) pursuant to RA 10121 and its Implementing Rules and Regulations supplemented by Local Budget Memorandum No. 87 dated June 9, 2023 and finalized by Local Budget Memorandum No. 87-A dated December 28, 2023, copy furnish the Office of the Sangguniang Panlalawigan of the reviewed LDRRMF;
- 6. That the appropriation and utilization of the 20% Development Fund shall be subject to the pertinent provisions of DBM-DOF-DILG Joint Memorandum Circular No. 1 dated November 4, 2020 and shall be identified or broken-down into specific/project component indicating the activities/programs to be undertaken and the *project site/location* in accordance with DILG-NEDA-DBM and DOF JMC No. 1 Series of 2016:

7. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

**RESOLVED FURTHER**, to inform the Municipality of Dinapigue, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable VICENTE D. MENDOZA**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Dinapigue, Isabela through the **Honorable REYNALDO D. DERIJE**, Municipal Vice-Mayor.
