ALBANO III TO SIGN ON BEHALF OF THE PROVINCIAL GOVERNMENT OF ISABELA A DEED OF DONATION FOR THE ACCEPTANCE OF A MOBILE DIGITAL X-RAY MACHINE WITH ACCESSORIES AMOUNTING TO FOUR MILLION SEVEN HUNDRED FORTY NINE THOUSAND EIGHT HUNDRED NINETY PESOS (PHP4,749,890.00) FROM THE DEPARTMENT OF HEALTH, TO BE ACCORDED TO PALANAN STATION HOSPITAL**

**WHEREAS**, the Department of Health (DOH) continuously provides support to local government units (LGUs) to strengthen healthcare services in the country through the donation of essential medical equipment to various health facilities;

**WHEREAS**, the Provincial Government of Isabela remains committed to improving healthcare services for its constituents and recognizes the importance of providing adequate medical equipment to district hospitals within the province;

**WHEREAS**, the Palanan Station Hospital is one of the vital healthcare facilities in the province, catering to the medical needs of Isabeleños from the province's coastal areas;

**WHEREAS**, the Department of Health, through its Health Facilities Enhancement Program, has offered to donate a mobile digital x-ray machine with accessories amounting to Php4,749,890.00 to the Provincial Government of Isabela which will be accorded to Palanan District Hospital to enhance its capacity to deliver quality healthcare services;

**WHEREAS**, in order to formalize the acceptance of the donation, a Deed of Donation must be executed between the Department of Health and the Provincial Government of Isabela, which is now the subject of review of this August Body;

**WHEREAS**, under Section 465(b)(1)(vi) of R.A. No. 7160, the Provincial Governor is authorized to sign contracts and agreements on behalf of the Province, upon prior authorization from the Sangguniang Panlalawigan;

**WHEREAS**, after careful review, this August Body finds the deed of donation to be just, lawful, and promotive of the health policies of the Provincial Government of Isabela hence it determined that it is in the best interest of the Provincial Government of Isabela to authorize the Honorable Governor Rodolfo T. Albano III to sign, on behalf of the province, the Deed of Donation with the Department of Health;

**WHEREFORE**, upon motion of the Honorable Emmanuel Joselito B. Añes, duly approved and seconded in a session duly assembled, it was –

**RESOLVED, AS IT HEREBY RESOLVED, TO PASS A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR RODOLFO T. 
**RESOLVED FINALLY**, that a copy of this resolution be furnished to Honorable Governor Rodolfo T. Albano III for his information.
