WHEREAS, the Provincial Government of Isabela recognizes the importance of enhancing disaster preparedness and response capacities to protect the lives and livelihoods of its constituents, particularly in light of the province's vulnerability to natural hazards such as typhoons, flooding, and landslides;

WHEREAS, the World Food Programme (WFP), a joint initiative of the United Nations and the Food and Agriculture Organization, supports efforts to boost disaster preparedness and response, with a focus on provinces like Isabela that are particularly at risk from natural hazards and climate-related challenges, providing critical resources to enhance local resilience and disaster management capabilities;

WHEREAS, the collaboration between the Provincial Government of Isabela and the World Food Programme (WFP) represents a proactive approach to building resilience against disasters, ensuring that the community is better equipped to handle emergencies and mitigate the impacts of climate-related risks;

WHEREAS, the World Food Programme (WFP), in alignment with its global mission to assist countries in enhancing disaster preparedness, has generously donated one (1) Mobile Storage Unit (MSU) valued at USD 11,800.00 (PHP 685,000.00) to the Provincial Government of Isabela to bolster the province's capacity for disaster risk reduction and management;

WHEREAS, the Mobile Storage Unit, with a capacity of up to 450 metric tons, will play a critical role in emergency response, providing much-needed storage for relief goods and other essential supplies during times of disaster and crisis;

WHEREAS, the donation includes not only the MSU but also the transportation, training, and technical support from WFP to ensure the proper use, deployment, and maintenance of the unit, thereby enhancing the preparedness of both provincial and municipal staff;

WHEREAS, this August Body acknowledges with deep appreciation the generosity of the World Food Programme (WFP) and its commitment to supporting the Provincial Government of Isabela in disaster risk reduction and management efforts;

WHEREAS, submitted to this August Body is the proposed Deed of Donation of the Mobile Storage Unit and Acceptance to be entered into by the PGI and the WFP;

WHEREAS, after careful review of the said deed, this August Body determined the same to be just, lawful, and promotive of the welfare of the Isabeleños;

WHEREAS, Section 465(b)(1)(vi) of R.A. No. 7160 empowers the Governor to represent the Province in all its transaction and sign contracts and such other documents relative to the execution of his functions, upon the authority vested in him by the Sangguniang Panlalawigan;

NOW, THEREFORE, upon motion of Honorable Victor G. Dy, duly approved and seconded in a session duly assembled it was –
