A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-07 (SUPPLEMENTAL BUDGET NO. 7 FY 2024) IN THE AMOUNT OF ONE MILLION SIX HUNDRED FIFTY THOUSAND ONE HUNDRED THIRTEEN PESOS & 80/100 (P1,650,113.80) OF THE MUNICIPALITY OF BENITO SOLIVEN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITIONS

WHEREAS, Appropriation Ordinance No. 2024-07, an Ordinance authorizing Supplemental Budget No. 7 of the Municipality of Benito Soliven, Isabela for Calendar Year 2024 involving an amount of ONE MILLION SIX HUNDRED FIFTY THOUSAND ONE HUNDRED THIRTEEN PESOS & 80/100 (P1,650,113.80) derived from the Loan Proceeds (8th release August 5, 2024) from Development Bank of the Philippines (DBP) to supplement the fund for the Construction of Multi-Purpose Building at Barangay District 2 (Phase V) of the Municipal Government of Benito Soliven, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-07 of the Municipality of Benito Soliven, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. That the One Million Six Hundred Fifty Thousand One Hundred Thirteen Pesos & 80/100 (P1,650,113.80) loan of the Municipality of Benito Soliven, Isabela, must be governed by Sec. 324 (b) of RA 7160, which states:

"That the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned."

2. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of Benito Soliven, Isabela to comply with the herein review finding and/or condition and notify this body of actions taken thereon.

RESOLVED FURTHERMORE, to inform the Municipality of Benito Soliven, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable ROBERTO T. LUNGAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Benito Soliven, Isabela through the **Honorable JOHN PAUL S. AZUR**, Municipal Vice-Mayor.
