**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-006 (SUPPLEMENTAL BUDGET NO. 006 FY 2024) IN THE AMOUNT OF SIX MILLION FIVE HUNDRED THOUSAND PESOS (P6,500,000.00) OF THE MUNICIPALITY OF NAGUILIAN, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS**

**WHEREAS**, Appropriation Ordinance No. 2024-006, an Ordinance authorizing Supplemental Budget No. 006 Series of 2024 involving the amount of **SIX MILLION FIVE HUNDRED THOUSAND PESOS (P6,500,000.00)** from the savings of the Municipal Government for Calendar Year 2023 for the implementation of the priority programs and projects of the Local Government of Naguilian, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**RESOLVED**, to declare Appropriation Ordinance No. 2024-006 (Supplemental Budget No. 006 S. 2024) of the Municipality of Naguilian, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The appropriation for the following account should be properly classified to specific Object of Expenditure and Account Code in accordance with COA Circular No. 2015-009 dated December 1, 2015, on Prescribing the Revised Chart of Accounts for LGUs:

2. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its Implementing Rules and Regulations;

**RESOLVED FURTHERMORE**, to inform the Municipality of Naguilian, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.




