**WHEREAS**, Appropriation Ordinance No. 417-2024, an Ordinance authorizing Supplemental Budget No. 01 Calendar Year 2024 in the amount of **FOUR MILLION SIXTEEN THOUSAND ONE HUNDRED FOUR PESOS & 70/100 (P4,016,104.70)** derived from the reversion of capital outlay- continuing appropriations to supplement the fund of MOOE under the Office of the Mayor, Municipal Government of Aurora, Isabela, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**NOW THEREFORE**, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

**THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:**

**RESOLVED**, to declare Appropriation Ordinance No. 417-2024 of the Municipality of Aurora, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The appropriation for Other Professional Services amounting to Three Million Six Hundred Sixty Four Thousand Four Hundred Pesos (P3,664,400.00) shall be in accordance with COA Circular No. 2015-009 dated December 1, 2015, on the Description of Accounts under the Revised Chart of Accounts for Local Government Units;
2. The appropriation for Donations amounting to Three Hundred Fifty One Thousand Seven Hundred Four Pesos & 70/100 (P351,704.70) shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
3. That all procurement activities must be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 revised Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Aurora, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Aurora, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable JOSEPH CHRISTIAN G. UY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Aurora, Isabela through the **Honorable MELVIN S. MARTIN**, Municipal Vice-Mayor.
