A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 422-2024 AS AMENDED BY ORDINANCE NO. 434-2024 (SUPPLEMENTAL BUDGET NO. 02 FY 2024) IN THE AMOUNT OF EIGHT MILLION FIVE HUNDRED FOUR THOUSAND NINE HUNDRED FIFTY NINE PESOS & 01/100 (P8,504,959.01) OF THE MUNICIPALITY OF AURORA, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 422-2024 as amended by Ordinance No. 434-2024, an Ordinance authorizing Supplemental Budget No. 02 for Calendar Year 2024 of the Municipality of Aurora, Isabela in the amount of **EIGHT MILLION FIVE HUNDRED FOUR THOUSAND NINE HUNDRED FIFTY NINE PESOS & 01/100 (P8,504,959.01)** from the savings of the share of the Municipality of Aurora, Isabela on the collection of Burley and Native Tobacco Excise Tax for Fiscal Years 2018 and 2019, was submitted to this Sanggunian for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 422-2024 as amended by Ordinance No. 434-2024 of the Municipality of Aurora, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. That the utilization of the project funded from the balances of the Local Government share in the Burley and Native Tobacco Excise Tax for Fiscal Years 2018 and 2019 in the amount of One Million Two Hundred Forty Eight Thousand Eight Hundred Ninety Six Pesos & 47/100 (P1,248,896.47) and Seven Million Two Hundred Fifty Six Thousand Sixty Two Pesos & 54/100 (P7,256,062.54), respectively shall adhere with the provisions of LBM Nos. 83 and 84 both dated November 22, 2021;
2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Aurora, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Aurora, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JOSEPH CHRISTIAN G. UY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Aurora, Isabela through the **Honorable MELVIN S. MARTIN**, Municipal Vice-Mayor.
