A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 427-2024 (SUPPLEMENTAL BUDGET NO. 03 FY 2024) IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (P100,000,000.00) OF THE MUNICIPALITY OF AURORA, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 427-2024, an Ordinance authorizing Supplemental Budget No. 03 for Calendar Year 2024 of the Municipality of Aurora, Isabela in the amount of **ONE HUNDRED MILLION PESOS (P100,000,000.00)** derived from New Revenue Source - Loan Proceeds to be allocated and utilized for the Construction of Three-Storey Aurora Multi-Purpose Hall Building at Brgy. Sili, Aurora, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 427-2024 of the Municipality of Aurora, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. That the One Hundred Million Pesos (P100,000,000.00) loan of the Municipality of Aurora, Isabela, must be governed by Sec. 324 (b) of RA 7160, which states:

"That the amount of Appropriations for debt servicing shall not exceed twenty percent (20%) of the regular income of the LGU concerned."

2. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.


RESOLVED FURTHER, to require the Municipality of Aurora, Isabela to comply with the herein conditions.

RESOLVED FURTHERMORE, to inform the Municipality of Aurora, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JOSEPH CHRISTIAN G. UY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Aurora, Isabela through the **Honorable MELVIN S. MARTIN**, Municipal Vice-Mayor.
