**A RESOLUTION DECLARING ORDINANCE NO. 42-2024 (SUPPLEMENTAL BUDGET NO. 04 FY 2024) IN THE AMOUNT OF SEVEN HUNDRED TWENTY THOUSAND TWO HUNDRED NINETY FOUR PESOS & 39/100 (P720,294.39) OF THE MUNICIPALITY OF DELFIN ALBANO, ISABELA OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, Ordinance No. 42-2024, an Ordinance authorizing Supplemental Budget No. 04 for Fiscal Year 2024 in the amount of **SEVEN HUNDRED TWENTY THOUSAND TWO HUNDRED NINETY FOUR PESOS & 39/100 (P720,294.39)** derived from savings from vacant position of the Municipality of Delfin Albano, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

**WHEREAS**, the subject Ordinance complies with the budgetary requirements, general limitations and other pertinent provisions set forth under Republic Act No. 7160.

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 42-2024 (Supplemental Budget No. 04 2024) of the Municipality of Delfin Albano, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The payment of *Terminal Leave Benefits and Monetization of Leave Credits* in the amount of Five Hundred Forty Nine Thousand Two Hundred Fifteen Pesos & 65/100 (P549,215.65) and Ninety Nine Thousand Six Hundred Forty One Pesos & 24/100 (P99,641.24) respectively, shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on the Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
2. The grant of additional *Representation and Transportation Allowances* to Officials in the amount of Seventy One Thousand Four Hundred Thirty Seven Pesos & 50/100 (P71,437.50) shall be in accordance with DBM Local Budget Circular No. 157, dated May 03, 2024 on the Updated rules and Regulations on the Grant of Representation and Transportation Allowances (RATA) to Officials of Local Government Units (LGUs) for FY 2024 and Years Thereafter;

**RESOLVED FURTHER**, to require the Municipality of Delfin Albano, Isabela to comply with the herein review findings/conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Delfin Albano, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.


