NOW THEREFORE, on motion of SP Member **DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-368 of the Municipality of Angadanan, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

- 1. The utilization of Terminal Leave Benefits in the amount of One Million Five Hundred Six Thousand Thirty Two Pesos & 20/100 (P1,506,032.20) shall be in accordance with DBM Budget Circular No. 2016-2 dated March 29, 2016, on the Computation and Funding of Terminal Leave Benefits and Monetization of Leave Credits, and CSC Memorandum Circular No. 02, s. 2016, on Amendment to the Constant Factor in the Formula used for Computing Terminal Leave Benefits (Section 40) and Computation of Leave Monetization (Section 24) of the Omnibus Rules on Leave;
- 2. The grant of additional Representation and Transportation Allowances to Officials in the amount of Five Hundred Fifty Six Thousand Eight Hundred Pesos (P556,800.00) shall be in accordance with DBM Local Budget Circular No. 157, dated May 03, 2024 on the Updated rules and Regulations on the Grant of Representation and Transportation Allowances (RATA) to Officials of Local Government Units (LGUs) for FY 2024 and Years Thereafter;
- The appropriation for the grant of Other Personnel Benefits Service Recognition Incentive (SRI) in the amount of Two Million Five Hundred Twenty Thousand Pesos (P2,520,000.00) shall be covered with appropriate guidelines and legal basis for its grant;
- 4. All procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations;

RESOLVED FURTHER, to require the Municipality of Angadanan, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FURTHER, to inform the Municipality of Angadanan, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable JOELLE MATHEA S. PANGANIBAN**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Angadanan, Isabela through the **Honorable DIOSDADO S. SIQUIAN**, Municipal Vice-Mayor.
