**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 06-2024 (SUPPLEMENTAL BUDGET NO. 03-2024) IN THE AMOUNT OF SIX HUNDRED FORTY SEVEN THOUSAND EIGHT HUNDRED PESOS (P647,800.00) OF THE MUNICIPALITY OF BURGOS, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO CONDITION**

**WHEREAS**, Appropriation Ordinance No. 06-2024, an Ordinance authorizing the appropriation of Supplemental Budget No. 03-2024 in the amount of **SIX HUNDRED FORTY SEVEN THOUSAND EIGHT HUNDRED PESOS (P647,800.00)** for the payment of electricity expenses and repairs and maintenance of transportation equipment to be implemented by the Mayor's Office of the Municipality of Burgos, Isabela, was submitted to this office for review, pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**RESOLVED**, to declare Appropriation Ordinance No. 06-2024 (Supplemental Budget No. 03-2024) of the Municipality of Burgos, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of R.A No. 7160, and subject further to the following conditions:

1. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

**RESOLVED FURTHER**, to require the Municipality of Burgos, Isabela to comply with the herein conditions.

**RESOLVED FURTHERMORE**, to inform the Municipality of Burgos, Isabela that this review action does not authorize any item of appropriation that is/are specifically prohibited by or inconsistent with the provisions of law, and that compliance with all the existing laws, rules and regulations shall be the responsibility of the Local Government Unit and disbursement of funds shall be subject to the usual budgeting, accounting and auditing rules and regulations.

**RESOLVED FINALLY**, to furnish a copy of this Resolution to the **Honorable ISIS DOMINIQUE T. UY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Burgos, Isabela through the **Honorable RUBEN A. GRAGASIN**, Municipal Vice-Mayor.
