A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 2024-004 (SUPPLEMENTAL BUDGET NO. 03 CY 2024) IN THE AMOUNT OF FIFTEEN MILLION TWENTY FIVE THOUSAND SIX HUNDRED THIRTY TWO PESOS & 56/100 (P15,025,632.56) OF THE MUNICIPALITY OF ECHAGUE, ISABELA OPERATIVE IN ITS ENTIRETY SUBJECT TO SOME CONDITIONS

WHEREAS, Appropriation Ordinance No. 2024-004, an ordinance approving Supplemental Budget No. 03, Calendar Year 2024, of the Local Government Unit of Echague, Isabela, appropriating the amount of **FIFTEEN MILLION TWENTY FIVE THOUSAND SIX HUNDRED THIRTY TWO PESOS & 56/100 (P15,025,632.56)** for the funding requirement of the implementation of the increase in pag-ibig contributions, creation of five (5) new casual positions of Administrative Aide I, SG-1 and other purposes of the Municipality of Echague, Isabela, was submitted to this Sanggunian for review pursuant to the provisions of Section 327 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the budgetary requirements and general limitations set forth under Republic Act No. 7160;

NOW THEREFORE, on motion of **SP Member DELFINITO EMMANUEL L. ALBANO** duly seconded:

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 2024-004 (2024 Supplemental Budget No. 03) of the Municipality of Echague, Isabela **OPERATIVE IN ITS ENTIRETY** subject to the posting requirements under Section 59 of Republic Act No. 7160 and subject further to the following conditions:

1. The creation of positions shall be consistent with the rules and regulations as prescribed under CSC Memorandum Circular No. 12, series of 2022. Further, creation of non-mandatory positions and offices in LGUs may be allowed subject to the following conditions:
 - a. That they are priority needs as identified by the LCE, the Sanggunian and/or LDCs concerned consistent with Section 17 of RA No. 7160;
 - b. All mandatory positions stipulated under RA No. 7160 and other pertinent laws have been created and provided;
 - c. The SSL has been fully implemented; and
 - d. The general limitations on PS expenditures are not exceeded;
2. The utilization of Terminal Leave Benefits and Monetization of Leave Credits shall be in accordance with CSC Omnibus Rules on Leave pursuant to CSC MC No. 41 s. 1998, BC 2013-1 dated April 12, 2013, BC No. 2016-2 dated March 29, 2016;
3. The appropriation for Pag-ibig Fund Contribution shall be in accordance with DBM Circular Letter No. 2024-2 dated February 1, 2024, on the Adjustment in the Employer (Government) Share in the Premium Contributions to the Home Development Mutual Fund (Pag-ibig Fund) effective February 2024;
4. The appropriation for Donations amounting to Four Million Pesos (P4,000,000.00) shall be solely spent for public purposes pursuant to Sections 305 (b), 335 and 351 of the LGC;
5. That all procurement activities shall be governed by the provisions of Republic Act No. 9184, the Government Procurement Reform Act (GPRA) and its 2016 Revised Implementing Rules and Regulations.

RESOLVED FURTHER, to require the Municipality of Echague, Isabela to comply with the herein review findings and/or conditions and notify this body of actions taken thereon.

RESOLVED FINALLY, to furnish a copy of this Resolution to the **Honorable FRANCIS FAUSTINO A. DY**, Municipal Mayor, and to the Sangguniang Bayan of the Municipality of Echague, Isabela through the **Honorable ALLAN P. TUPONG**, Municipal Vice-Mayor.
